## F. Appointed Board Member's Report- Chris Haulmark

As a board member and chair of the Social Justice committee, Chris provided a report. He said he had been contacted by Deaf individuals, including those who had experienced workplace discrimination. He has been working with them to develop their self advocacy skills, and he has referred them to Robert Cooper, of KCDHH, and the Equal Employment Opportunity Commission. He has also tracked down those in administrative roles who should be contacted to reduce the discrimination. There were some who misunderstood the ADA laws, which Chris clarified.

When it comes to public services, Chris has been very active advocating for the Deaf community. He explained that changes are willing to happen when the request comes from a large organization such as the KAD. He also mentioned that there have been more complaints about hospitals being inaccessible. According to him, VRI is being used more and more, and appointment scheduling is determined by the availability of interpreters on staff.

The topic of repeat introduction of a legislation bill regarding the requirement of documentation to prove disability when requesting a service or emotional animal from housing providers was discussed.
